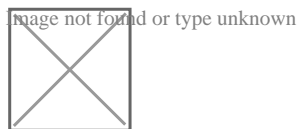
Common Types of Corporations

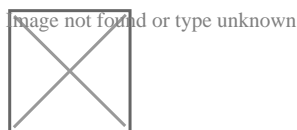
